Program Aide/CIT Code of Conduct

I understand that my attitude and behavior are critical to the success of any Girl Scout event. Therefore, for the good of the camp, as well as for my fellow members, I agree to abide by the following:

- ❖ Remember that I represent Girl Scouts – GSGMS and GSUSA; and that behavior appropriate to the Girl Scout Promise and Law is expected at all times.
- ❖ I will be sensitive to needs of each event participant by performing my assigned duties including, but not limited to kapers, clean-up, program planning, etc.
- ❖ I will respect the places and people with whom I come in contact. I will not make inappropriate remarks or gestures.
- ❖ I will be responsible for my personal belongs and equipment and will not hold the camp sponsor responsible for their loss or damage. I understand that electronics, including cell phones, are not allowed in cabins or tents and must be kept in the Director's office except during meals.
- ❖ I understand that the use of tobacco, alcohol, or drugs will not be tolerated, and that usage during the camp will result in expulsion from the event/trip.
- ❖ I understand that I may not leave the campsite in my own vehicle or in anyone else's vehicle without providing the camp director with written permission from my parents.
- ❖ I will use any safety equipment furnished by the camp sponsor for my own safety. I will observe safety precautions for all activities within the camp program. Such observation will include staying with my buddy at all times, being supervised by an adult volunteer or staff at all times and utilizing all other safety precautions that will be discussed with participants.
- ❖ I understand that if I am sent home early due to any serious misconduct, my camp fees will not be refunded. I also understand that this may result in my exclusion from future camps. Both parent/guardian and participant must sign the Code of Conduct.
